

# Commercial Lighting Rebate

KPUB is continuing its Commercial Lighting Energy Efficiency Program. It is a Rebate/Incentive program that provides funds directly to KPUB customers who install new lighting in Commercial/Business retrofit projects and new installations. For new construction projects, rebates will only be paid for LED fixtures.

A rebate will be paid directly to the KPUB customer who completes and submits all required documentation of the lighting purchase and installation.

Rebate includes:

- **LED Replacement Fixtures: up to \$30.00 per fixture (actual cost of fixture)**
- **LED Bulb Replacement: 30% of bulb cost up to a maximum of \$10.00 per bulb\***
- **T-12 to T-8 or LED Retrofit: up to \$20.00 per fixture (actual cost of fixture)**
- **LED Exit Signs: up to \$15.00 per fixture (actual cost of fixture)**
- **Occupancy Sensors: up to \$20.00 (actual cost of fixture)**
- **Maximum rebate: \$2,500.00**

Maximum of one rebate per customer site.

## **KPUB Commercial Lighting Rebate Requirements:**

- Must be a current KPUB customer (Commercial/Business only)
- This rebate applies only to Commercial/Business Accounts only
- Rebates are paid based on dated invoice for materials only. Receipts for fixtures, bulbs and sensors must be submitted to receive reimbursement.
- All new building projects require the installation of LED fixtures and lamps
- All building improvements and retrofit projects require LED and/or fluorescent fixtures and lamps (T8 with an electronic ballast of 28 watts or less)
- All lighting must be new and installed per manufacturers installation requirements and be UL approved
- New LED products and new T-8 linear fluorescent lighting equipment must be listed on the DesignLights Consortium® (DCL) Qualified Products List (QPL).\*
- Pre-approval and site inspections of the project will be required prior to the work being performed
- State and local codes must be followed
- Completed applications must be submitted to KPUB along with all accompanying documentation no later than October 31, 2018 – for lighting installed between October 1, 2017 and September 30, 2018.
- Limit one lighting rebate per customer site – maximum rebate \$2500.00 (while funds last)
- KPUB reserves the right to change the program at any time
